### Members' rights to petition

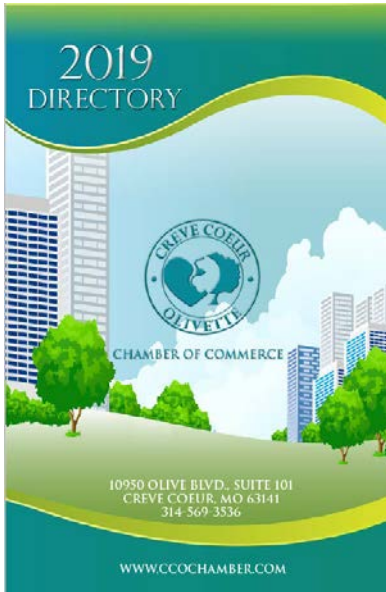
According to Article IV, Section 2C of our bylaws, "Additional names of candidates for Directors may be nominated by petition bearing the genuine signature of at least fifteen (15) qualified members of the Association. Such petition shall be filed with the Executive Vice President within ten (10) days after notice has been given with the names of those nominated. The determination of the nominating committee, as to the legality of the petitions(s), shall be final."

### Procedures followed in case of petition and the election of the Class of 2021

Under Section 2D, "If a legal petition shall present additional candidates, the names of all candidates shall be arranged on a ballot in alphabetical order. Instructions will be to vote for six (6) candidates only. The Executive Vice President shall mail, e-mail or fax this ballot to all active members at least fifteen (15) days before the regular November Board meeting. The ballots shall be marked in accordance with instructions printed on the ballot and returned to the Association office within ten (10) days. The Board of Directors shall, at its regular November Board meeting, declare the six (6) candidates with the greatest number of votes, elected.

If no petition is filed within the designated period, the nominations shall be closed and the six (6) candidates shall be voted on individually by the Board of Directors at its regular November Board meeting."

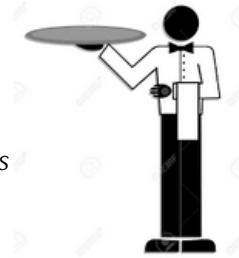
